


## W | A | M Alternative Assets

The WAM Alternative Assets (ASX: WMA) investment portfolio increased during the month, primarily driven by the underlying performance of its infrastructure investments.

In December, WAM Alternative Assets' investment partner Adamantem Capital announced a new investment in Mason Stevens via the Adamantem Capital Fund II. Founded in 2010, Mason Stevens is a leading specialist wealth management platform and investment services business for financial advisers and wealth practices. Mason Stevens is well positioned in the growing financial advice market, targeting an attractive and high growth segment, with the business' scalable digital platform and unique value proposition providing differentiated investment solutions for its core customers. This investment increases the WAM Alternative Assets investment portfolio's exposure to high-growth private equity investments. We are excited by the investment opportunity in a strong strategic growth agenda.

During the month, WAM Alternative Assets' investment partner Wentworth Capital announced the acquisition of 100-130 Harris Street, Pyrmont, a trophy creative office asset in Sydney, via the Wentworth Real Estate Private Equity Fund I (WREPEF I). The property provides a compelling rental yield, is occupied by blue-chip tenants on long-term leases and has strong environmental credentials. We are excited to gain exposure to this high-quality real estate asset via our investment in WREPEF I, with multiple value-add opportunities including future rental upside and development potential.






