- R&D Facility (\$30 million) which carries an interest rate of BBSW+5.5% and commitment fee of 40% of the margin on undrawn amounts (drawn to \$1.827 million as at Quarter-end; and
- Performance Bond Facility (\$5 million) which carries an interest rate of BBSW+10.0% and had an outstanding balance of \$4.8 million as at Quarter-end.

Documentation of the Midstream Infrastructure Facility is expected to be completed in Q1 2025.
