8.8.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
Answer: No. While the prescribed calculation in 8.7 indicates that there are 52 quarters of cash remaining, the Company notes that the capital development and pre-production costs for the Lance Projects are not included in the calculation. Accordingly, net operating expenses will increase from that shown above as production ramp-up continues in future quarters. Please also refer to ASX Announcement "Update on the Central Processing Plant Commissioning" dated 31 January 2025. The Company continues to progress a number of additional funding options, including potential government funding support through the US Department of Energy and independent third parties who have expressed interest to potentially provide funding.
