Completion of acquisition of Uecomm

Superloop Limited (**ASX: SLC**) ("Superloop") today announces it has completed the acquisition of Uecomm Pty Ltd (Uecomm) that was announced on <u>9 December 2024.</u>

The acquisition of the fibre assets adds over 2,000 kilometres of high-capacity fibre assets (including 800 kilometres of owned duct) and provides access to more than 1,900 buildings and approximately 50 data centres. The acquisition also increases the size of Superloop's network in Sydney, Melbourne and Brisbane/Gold Coast central business districts and metropolitan areas, complements our existing network, and expands our high-speed data and internet service offering across our three segments.

Superloop CEO and Managing Director, Paul Tyler said, "The addition of these fibre assets to our network supports our Smart Communities ambitions, lowering capex connections to new buildings and broadacre developments. Our focus for the next 12 to 15 months will be on transitioning operations, productising the asset, and realising on-net synergies across our existing building footprint. Superloop will continue to consider other opportunities to support the growth ambitions laid out in its three-year 'Double Down' strategy".

Today's announcement follows the release of Superloop's strong H1 FY25 results on <u>21 February</u> 2025.
