487,762 of the shares were issued under the Company's Loan Funded Share Plan (LFSP) in 2022 as long term incentives, subject to certain vesting conditions which have not been met. The remainder of the shares were issued under the LFSP in 2023 and 2024 and were forfeited on the holder leaving the business. Under the terms of the LFSP, all shares will be bought back for an amount equal to the outstanding loans taken out to acquire them, being an average price of \$7.129022 per share.
