ASB has agreed to pay the JLMs, in their respective proportions (being two thirds in the case of JPM and one third in the case of EHL) a base fee of 2.5% of the proceeds of the placement (excluding the gross proceeds raised from certain existing substantial investors). There is also the potential for an incentive fee equal to up to 1% of the proceeds of the placement at the ASB Board's sole discretion (excluding the gross proceeds raised from certain existing substantial investors).
