

Youanmi High-Grade Gold Hits Continue

West Australian gold exploration and development company, Rox Resources Limited (“Rox” or “the Company”) (ASX: RXL), is pleased to announce the latest assay results from its Step-up drilling program at the Youanmi Gold Project in Western Australia, which continue to return multiple high-grade gold intersections and further define new zones of mineralisation.

Highlights:

- Step-up drilling program on schedule and within budget, with four drill rigs on-site and further results pending
- Site works are on track with dewatering infrastructure delivered in advance of installation
- Metallurgical test work program, including comminution and flotation testing, is largely completed, with AlbionTM test work on the concentrate underway.

Rox Resources’ Managing Director & CEO, Phillip Wilding, commented:

“Drilling continues to deliver high-grade results that will increase the mineral resource and reserves and underpin the new DFS and mine plan. All holes in this ~35,000 metre drill program are focused on resource extensions.

Shallow, high-grade results from Prospect will link the Main zone with Pollard and provide much-needed high-quality ore early in the mine plan. More drilling is planned to fully prove the potential of this area.

Holes immediately north of Youanmi Main continue to deliver economic intersections that will also result in a resource and reserve upgrade in the DFS.

Over the next month there will be significant activities getting underway with dewatering infrastructure installation and commissioning, along with advancing the various workstreams to deliver the DFS and aiding in commencement of early works.”

March Drilling Results

Prospect

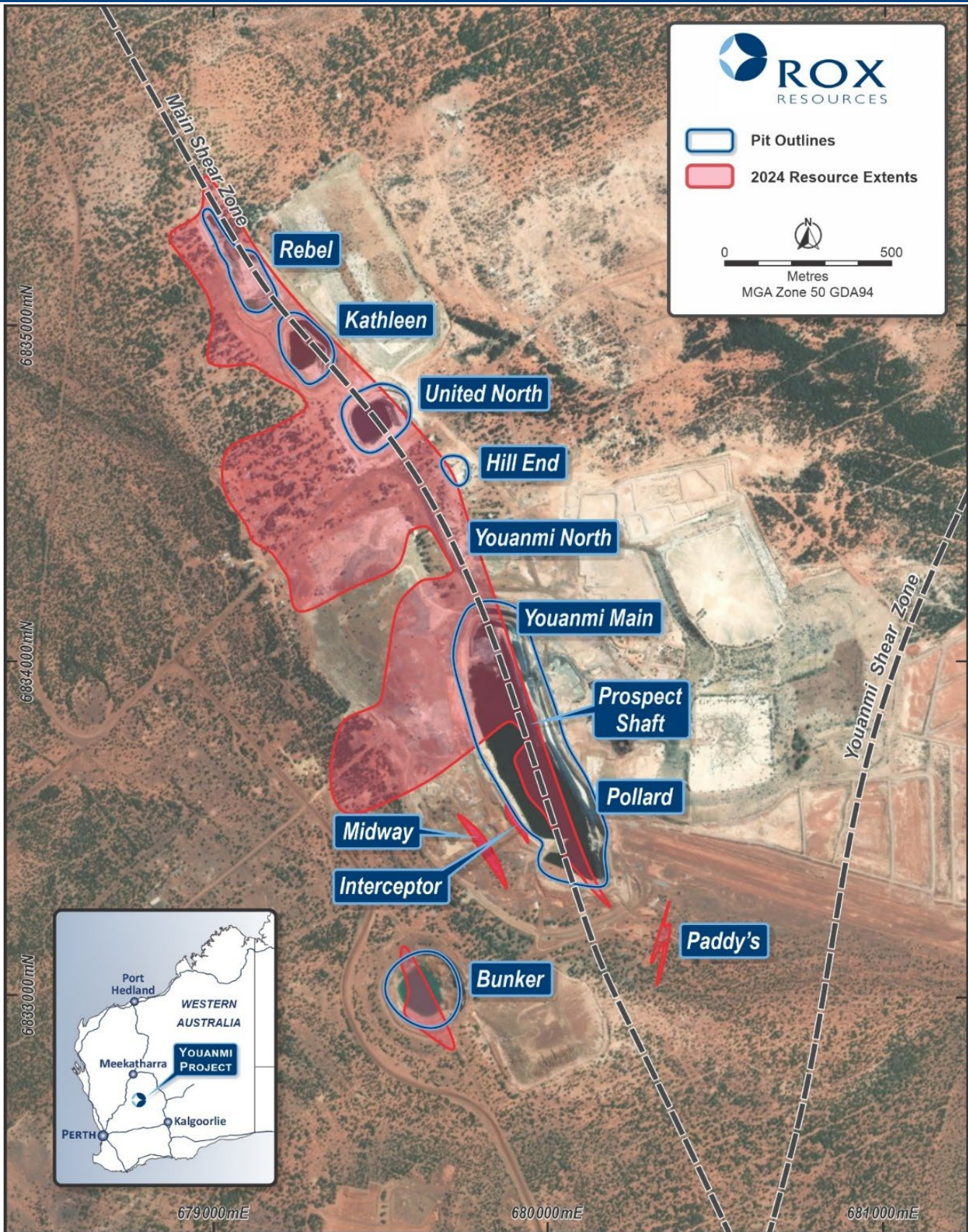


Figure 1: Plan view featuring focus areas of the Step-up drill campaign and Prospect shaft, overlain on the 2024 MRE outline (red polygons) – note Midway, Interceptor and Paddy's are projected surface expressions.

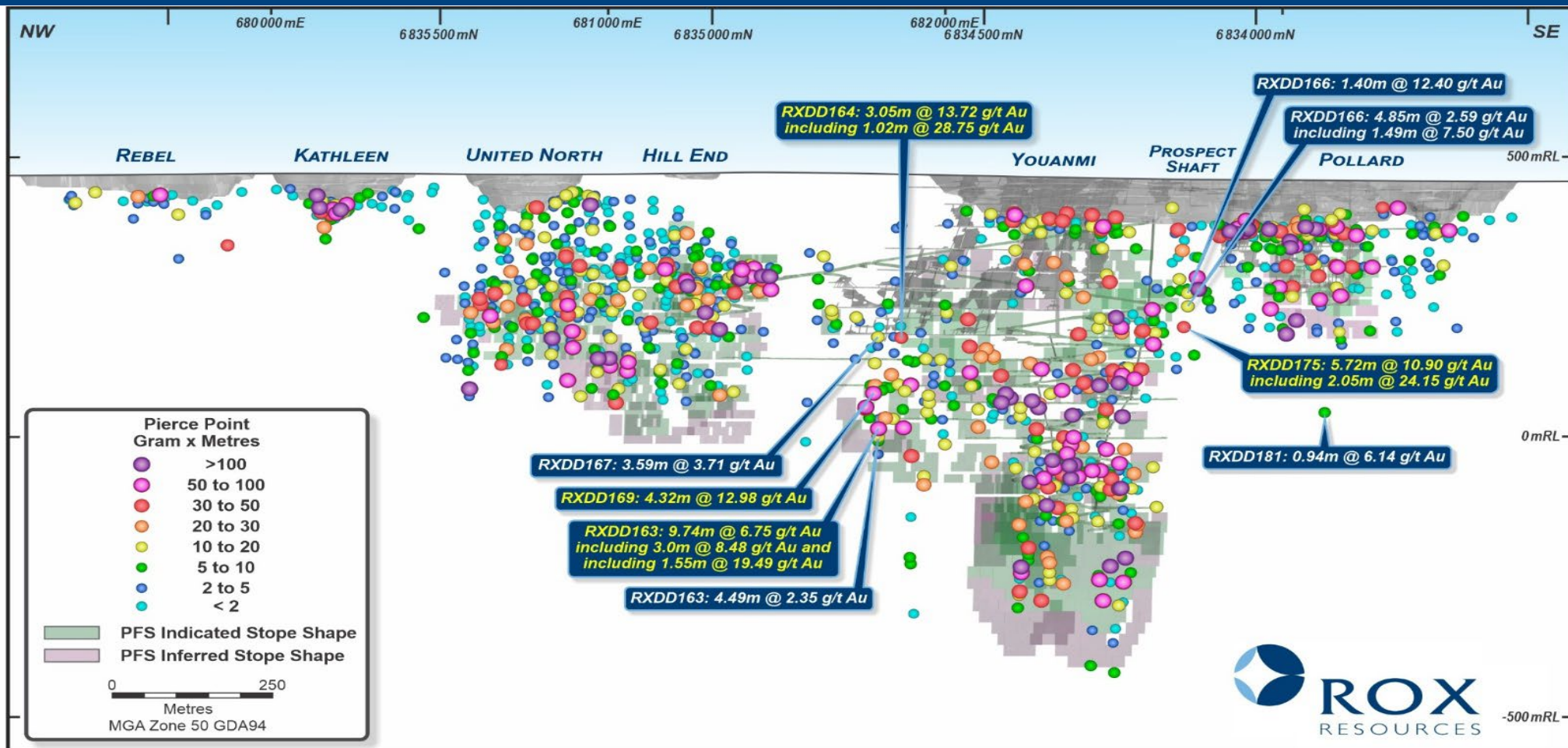


Figure 2: Long section featuring; (i) recent Step-up drill campaign drill hole pierce points, (ii) 2024 PFS stope shapes, (iii) existing development, and (iv) significant intercepts from the March 2025 Step-up campaign.

Results announced today prove the down-dip continuity of high-grade shoots of the two Prospect lodes (Figures 1 & 2). The two parallel structures can now be projected >200 metres beneath the historic workings and 160 metres below the base of the Main Pit. They are the deepest holes under Prospect and are outside the existing resource.

Significant results include:

- **RXDD175: 5.72m @ 10.90g/t from 285.4m**
- **RXDD166: 1.40m @ 12.40g/t from 236.6m**
- **RXDD166: 4.85m @ 2.59g/t from 258.0m**

Youanmi Main

Assay results from drilling north of Youanmi Main (Figures 1 & 2) confirms continuity of high-grade shoots into areas outside the current resource, where high-grade intercepts align with predicted down-plunge extensions to known mineralisation.

Significant results include:

- **RXDD163: 9.74m @ 6.75g/t from 466.8m**
- **RXDD169: 4.32m @ 12.98g/t from 444.6m**
- **RXDD164: 3.05m @ 13.72g/t from 336.7m**
- **RXDD167: 3.59m @ 3.71g/t from 338.5m**

Pollard

The deepest hole to date confirms that the Main Lode shear continues through this area (Figure 2). Drilling has been paused while the Company awaits assay results that are expected in April.

Significant results include:

- **RXDD181: 0.94m @ 6.14g/t from 463.3m**

January results summary

Assay results² confirmed shallow mineralised extensions beneath both the Rebel and Kathleen pits, and the continuity of mineralisation below the current resource outline.

At United North, economic-grade intersections below the base of the resource confirmed the continuation of plunging high-grade shoots at depth.

Detailed logging, supported by assay results at Pollard, confirmed the presence of high-grade shoots plunging directly below the modelled resource.

Drilling north of Youanmi Main area confirmed the continuity of high-grade shoots at Youanmi Main.

February results summary

Mineralised down-dip extensions of high-grade gold mineralisation identified in the Prospect area, outside the existing resource, with further drilling in progress.

Assay results from drilling in the Youanmi to United North area verify the continuity of high-grade shoots into previously unclassified areas and will be included in the MRE update later in the year.

Current Status of Drilling Activities

Drilling has focused on the key deposits along the high-grade, 1.8 kilometre-long Youanmi mineralised corridor (Figure 1), with the latest update as outlined below:

- Drill campaign is on schedule and within budget to deliver 35,000 metres of drilling for \$11 million at the end of April;
- Approximately 23,000 metres of DD drilling and 8,384 metres of RC drilling has been completed;
- Sample processing is up to date with more than 12,600 samples received by Bureau Veritas (BV) laboratory so far; and
- Drilling continues at Youanmi North, United North and Prospect.

35,000 metre Step-up Drilling Program

In December 2024, DDH1 and Strike Drilling were contracted to deliver a circa 35,000 metre drill campaign, which has the following aims:

- Grow the gold resource around near-mine areas, as outlined in the Pre-Feasibility Study ("PFS")³ and
- Deliver a larger Indicated resource that will feed into the reserve that underpins a Definitive Feasibility Study ("DFS").

A revised mine plan from the DFS is aimed at delivering higher ore throughput rates and higher gold production per annum than previously reported, thereby reducing the capital payback period.

Results to date have been extremely encouraging in improving resource confidence, opening growth opportunities and refining the geological understanding of the broader mineralised system.

Indicative Pathway to Production⁴

The Indicative Pathway to Production remains on track with drilling on time and budget, dewatering civil engineering work under way, evaporation ponds close to completed and pipe/pump installation to commence in coming weeks. Comminution/flotation metallurgical test work is largely completed, with AlbionTM test work on the concentrate having commenced.

About Rox Resources

Rox Resources (ASX: RXL) is a West Australian focused gold exploration and development company. It is the 100 per cent owner of the historic Youanmi Gold Project near Mt Magnet, approximately 480 kilometres northeast of Perth, and owns the Mt Fisher - Mt Eureka Gold and Nickel Project approximately 140 kilometres southeast of Wiluna, with 100% ownership of certain tenure with the remaining tenure held via a joint venture (Rox 51%, earning into 75%).

Youanmi Project has a Total Mineral Resource of 2.3Moz of contained gold, with potential for further expansion with the integration of existing prospects into the Resource and further drilling. Youanmi was a high-grade gold mine and produced ~667,000oz of gold (at 5.47 g/t Au) before it closed in 1997. It is classified as a disturbed site and is on existing mining leases which have significant existing infrastructure to support a return to mining operations.

Competent Persons Statement

Exploration Results

Resource Statements

The statement of estimates of Mineral Resources for the Youanmi Gold Project was reported by Rox in accordance with ASX Listing Rule 5.8 and the JORC Code (2012 edition) in the announcement "MRE Update confirms Youanmi as Significant High-Grade Gold Project and Paves Way for PFS" released to the ASX on 30 January 2024, and for which the consent of the Competent Person Mr Steve Le Brun was obtained. Rox confirms it is not aware of any new information or data that materially affects the Mineral Resources estimates information included in that market announcement and that all material assumptions and technical parameters underpinning the Mineral Resources estimates in that announcement continue to apply and have not materially changed. Rox confirms that the form and context in which the Competent Person's findings are presented have not been materially modified from that market announcement.

Production Target

The Production Target and forecast financial information derived from the Production Target referred to in this release are underpinned by Indicated Mineral Resources (approximately 71%) and Inferred Mineral Resources (approximately 29%). The total Life of Mine Production Target includes 29% Inferred Resources ounces, 7% Indicated Resource ounces outside of Reserve and the remaining 64% is underpinned by Probable Ore Reserves. There is a low level of geological confidence associated with Inferred Mineral Resources and there is no certainty that further exploration work will result in the determination of Indicated Mineral Resources or that the Production Target or forecast financial information reported will be realised. Accordingly, the Company has scheduled the Production Target such that Inferred Mineral Resources do not feature as a significant proportion of the first 4 years of the 9-year mine plan. Approximately 19% of the Production Target material mined over the first 4 years is underpinned by Inferred Mineral Resources. The Company is satisfied that the Inferred Mineral Resources partially underpinning the Production Target is not the determining factor of the viability of the Youanmi Gold Project.

Pre-Feasibility Study
