This on-market share buy-back is part of the Company's total distribution amount for the half year ended 31 December 2024 of US5.0 cents per share (US\$39.0 million), comprising an unfranked interim cash dividend of US2.5 cents per share and the undertaking of an on-market share buy-back for US\$19.5 million (equivalent in total to US2.5 cents per share).
