Q1 FY25 Quarterly Activity Report and Appendix 4C

Q1 FY25 Highlights

- Continuation of revenue growth (excluding Google¹) on prior corresponding period (pcp)
 - Revenue for Q1 FY25 was \$50.2 million, down 14% on pcp (which included \$13.4 million of revenue from Google).
 - Excluding Google, revenue for Q1 FY25 grew 12% on pcp (from \$45.0 million in Q1 FY24).
- Significant EBITDA improvement on pcp
 - Underlying EBITDA² (before FX) for Q1 FY25 was a loss of \$1.5 million, a \$1.4 million improvement on pcp loss of \$2.9 million.
- Cash balance remains healthy
 - Cash on hand as at 31 March 2025 was **\$67.9 million**.

Appen Limited (Appen) (ASX: APX) is pleased to provide this activity report and Appendix 4C for the quarter ended 31 March 2025. Unless noted otherwise, all figures are presented in US\$ and January 2025 to March 2025 are based on unaudited management accounts.

There were no material changes to Appen's principal activities during the quarter.

Commenting on the performance for the quarter, Appen's CEO & Managing Director Ryan Kolln said, "Q1 was a solid start to the year and sets the foundation for delivering profitable growth in FY25. Due to the cyclical nature of the revenue, it is important to highlight that revenue has historically skewed to the second half of the year and we anticipate FY25 will continue this trend."

"We're continuing to experience LLM-related growth which is contributing to our positive revenue performance. China continues to experience significant revenue growth, and we have conviction in the potential of our Enterprise and Government divisions."






Group Revenue

Notes related to cash balance

Cash on hand as at 31 March 2025 was \$67.9 million, up \$13.1 million from \$54.8 million at 31 December 2024.

Net cash from operating activities was \$16.6 million for the quarter, compared to \$12.4 million used in Q4 FY24. Operating cash flows were positively impacted by the \$10.0 million received from a major customer on 4 January 2025 noted in the previous quarterly activity report as well as strong Q4 FY24 trading.

Q2 FY25 cash from operating activities may be impacted by annual payments scheduled for the quarter, as well as general working capital cycles.

Staff costs includes employed direct project workers (crowd expenses). This amount was \$6.2 million for the quarter, up from \$5.6 million in Q4 FY24. The increase aligns with revenue growth for projects requiring employed project workers.

Net cash used in investing activities was \$3.1 million for the quarter, largely in line with \$3.0 million in Q4 FY24. \$2.8 million outflow in relation to intellectual property refers to capitalised investment in product development.

Appendix 4C item 6.1 includes \$0.3 million aggregate payments to the CEO and Managing Director and Independent Directors. All amounts paid were in their capacity as Executive and Independent Directors.
