CAQ Holdings Limited March 2025 Quarter Activities Report

Operations Review

The property leasing business decrease in March 2025 Quarter. Leasing revenue totalled RMB2.0 million (AUD 426.3k) during the March 2025 Quarter, slightly down from RMB2.1 million (AUD 447.6k) in the December 2024 Quarter, representing a decrease of approximately 5%.

The status of the exhibition centre remained unchanged from the December 2024 Quarter, the system integration testing was suspended pending release of new government customs requirements.

The existing vacancy (including areas subject to negotiation) rate being:

Warehouse $(41,750m^2)$	37%	(37% in December 2024)
Factories (17,784m ²)	66%	(66% in December 2024)
Exhibition Centre*	95%	(95% in December 2024)
Administrative Building	46%	(46% in December 2024)

A number of contracts of the vacant areas are under negotiation. According to the national plan of China, Hainan Island will be established as a free trade port by the end of 2025. Potential new tenants are still looking to the policies to be promulgated by the Chinese government prior to making a decision on entering into the tenancy agreements. While Government policies provide the potential for a higher level of interest in leasing assets, the final nature of policy directives remain uncertain at the moment, consequently there may be timing delays for increased revenue inflows. We are also uncertain of the trade war bring to the overall economic development of China, which may cause changes in the implementation of the national policies.

During the March 2025 Quarter CAQ's receipts from customers was \$0.46m (RMB2.0 million) which was increase from the December 2024 Quarter \$0.39m (RMB1.8 million).

Financial

At the end of the Quarter the Group had cash at bank of \$0.09m.

Payments to director related parties and their associates during the quarter totalled \$Nil.
