## LEADERSHIP UPDATE

Fortescue Ltd (Fortescue, ASX: FMG) is pleased to announce a refinement of its leadership structure. Dino Otranto, Chief Executive Officer (CEO) Metals and Operations, will assume an expanded role to include operational responsibility for global electrification and decarbonisation (incl. Fortescue) and production of hydrogen products.

Agustin (Gus) Pichot has been appointed Fortescue's CEO Growth and Energy, effective 1 July 2025. He will be responsible for the Company's green energy development and growth projects.
