Form 605 – Notice of ceasing to be a substantial holder

Aussie Broadband Limited (**ASX:ABB**) ("**Aussie Broadband**" or "**the Company**") wishes to advise that following a disposal of shares on 29 May 2025, Phillip Britt, Non-Executive Director and Special Technical Advisor, has ceased to be a substantial holder in Aussie Broadband. The disposal of shares was effected to fund commitments relating to Rural Fibre Co, Mr Britt's community-oriented wholesale infrastructure fibre provider in Gippsland, Victoria.

Mr Britt remains committed to Aussie Broadband as a Non-Executive Director, Special Technical Advisor, and a large shareholder. As of 2 June 2025, Mr Britt holds 14,284,734 million shares, representing a 4.98% holding in the Company.

The Company's trading window is now closed until the business day following the release of its financial results for the financial year ending 30 June 2025 (FY25).


