The Company is pleased to announce the appointment of Mr Wayne Bull as Non-Executive Director. Wayne is a Mining Engineer with over 40 years of experience in the resources sector and a track record of delivering improved strategic, operational, commercial and technical performance. Wayne has held senior roles with Thiess Contractors and WDS Limited and is currently an Executive Advisor to M Resources. Andrew Kazakoff, GM Business Development of M Resources, will be appointed as Alternate Director for Mr Bull.
