Notice under sections 708A(5)(e) and 1012DA(5)(e) of the *Corporations Act 2001* (Cth)

This notice is given by DigiCo Infrastructure REIT (ASX: **DGT**), a stapled group comprising HMC Digital Infrastructure Ltd (ACN 682 024 924) (**DigiCo StapleCo**) and Equity Trustees Limited (ACN 004 031 298) (AFSL 240975) in its capacity as responsible entity of the HMC Digital Infrastructure Trust (ARSN 682 160 578) (**DigiCo Trust**), under sections 708A(5)(e) and 1012DA(5)(e) of the *Corporations Act 2001* (Cth) (**Corporations Act**).

Capitalised terms used but not defined in this notice have the meaning given in the replacement prospectus and product disclosure statement lodged with the Australian Securities and Investments Commission on 5 December 2024.

DGT has today issued Securities to the Investment Manager's nominee pursuant to the Investment Management Agreement between DGT and the Investment Manager in satisfaction of DGT's obligation to pay the Management Fee for the period from Completion until 31 May 2025.

DGT gives notice under sections 708A(5)(e) and 1012DA(5)(e) of the *Corporations Act*, that:

- 1 DGT has issued 1,967,161 Securities without disclosure to investors under Part 6D.2 and Part 7.9 of the *Corporations Act* and without a prospectus or product disclosure document for the Securities being prepared;
- 2 as disclosing entities, DigiCo StapleCo and DigiCo Trust are subject to regular reporting and disclosure obligations;
- 3 as at the date of this notice, DGT has complied with:
 - a. the provisions of Chapter 2M of the *Corporations Act* as they apply to DGT (including as they apply to HMC Digital Infrastructure Trust); and
