**Consolidation of Mammoth Ownership** 

Intelligent Monitoring Group Limited ("IMG or Company") is pleased to confirm that it has moved to consolidate its ownership of its subsidiary, Mammoth Security Pty Ltd ("Mammoth").

When IMG acquired Adeva Home Solutions Pty Ltd in May 2024, it did so by issuing shares in Mammoth to the Adeva vendors as part of re-activating the Signature Security brand. Effective 1 July 2025, IMG will acquire the remaining shares in Mammoth from the Adeva vendors and extinguish the earn out payable to the Adeva vendors ("Mammoth Consolidation").<sup>1</sup>

This change will allow IMG to refine its go-to-market strategy for its three principal brands. Entering FY26 IMG has three principal brands: ADT [AU/NZ] and its subsidiaries (ACG, AAG, DVL & Kobe) a direct to market brand, Signature Security (our industry partnered brand) and Intelligent Monitoring Solutions (our wholesale monitoring operation in AU).

Following this change, Signature Security will launch its "Signature Partner Program" in late August at the Australian Security Industry Association Ltd (ASIAL) conference in Sydney. Designed for wholesale customers, the program offers access to IMG Group's buying power and shared services to help partners scale high-quality, professional-grade video monitoring solutions with minimal overhead. It aims to drive growth, create recurring revenue, and foster a long-term, mutually beneficial relationship.

The Company advises that it has agreed to pay \$1,500,000 to the Adeva vendors in consideration for the Mammoth Consolidation, comprising an issue of 1,636,364 ordinary fully paid IMG shares at \$0.55 per share, and \$600,000 in cash.
