## **COURT APPROVES SCHEME**

Donaco International Limited (**Donaco** or the **Company**) is pleased to announce that the Supreme Court of New South Wales (**Court**) has today made orders approving the proposed scheme of arrangement between Donaco and its shareholders under which On Nut Road Limited (**ONR**) will acquire 100% of the shares in Donaco that it does not already own (**Scheme**).<sup>1</sup>

## **Lodgement of Court Orders and Suspension of Trading**

Pursuant to section 411(10) of the *Corporations Act 2001* (Cth), the Scheme will become legally effective upon lodgement of the Court orders with the Australian Securities and Investments Commission (**ASIC**).

Donaco expects to lodge an office copy of the Court's orders with ASIC tomorrow (Friday, 8 August 2025), at which time the Scheme will become legally effective (**Effective Date**). If this occurs, it is expected that Donaco shares will be suspended from trading on the ASX with effect from the close of trading on Friday, 8 August 2025.
