***AI-Media Board transition underlines continuity: Alison Loat retires at 2025 AGM, with two new US-based independent directors appointed in 2024***

AI-Media Technologies Limited (“AI-Media” or “the Company”) today announces that Ms Alison Loat, Independent Non-Executive Director, has advised that she will not stand for re-election at the Company’s 2025 Annual General Meeting (“AGM”) on 26 September 2025 and will retire from the Board at the conclusion of the AGM.

Alison joined the Board in March 2018 following two years providing strategic support to the business, and has been a highly valued contributor over the past nine years. She served with distinction as Chair of the Remuneration and Nomination Committee and a member of the Audit and Risk Committee.

Chair John Martin said:

“On behalf of the Board, I sincerely thank Alison for her outstanding service and commitment to AI-Media. As our first North American-based director, Alison brought invaluable international perspective and deep local knowledge that were instrumental in establishing and expanding our presence in North America.

Alison has also played an important role in guiding AI-Media through its transformation from a private Australian captioning services company with a predominately Australian client base to an ASX-listed global leader in AI-powered captioning, voice translation, and language orchestration.

Following her long tenure with the company, and with two new US-based, technology-experienced non-executive directors joining the Board in December 2024, Alison felt this was the right time to step back. We are grateful for her service and the impact she’s had on the company. We will miss her contributions, and wish her every success in the future.”
