## Less risk than the market

The WAM Alternative Assets investment portfolio has increased 5.3%\* in the 2025 financial year and 8.9%\* per annum since the appointment of Wilson Asset Management as Investment Manager in October 2020. Pleasingly, the investment portfolio performance has been achieved with significantly less volatility, as measured by standard deviation, than public markets. Standard deviation compares the dispersion of returns from its average. A lower standard deviation is an indicator of more consistent returns with lower risk levels. Since the appointment of Wilson Asset Management as Investment Manager, the investment portfolio performance has been achieved with a standard deviation of 3.1% per annum, compared to the S&P/ASX All Ordinaries Accumulation Index standard deviation of 13.0% per annum.

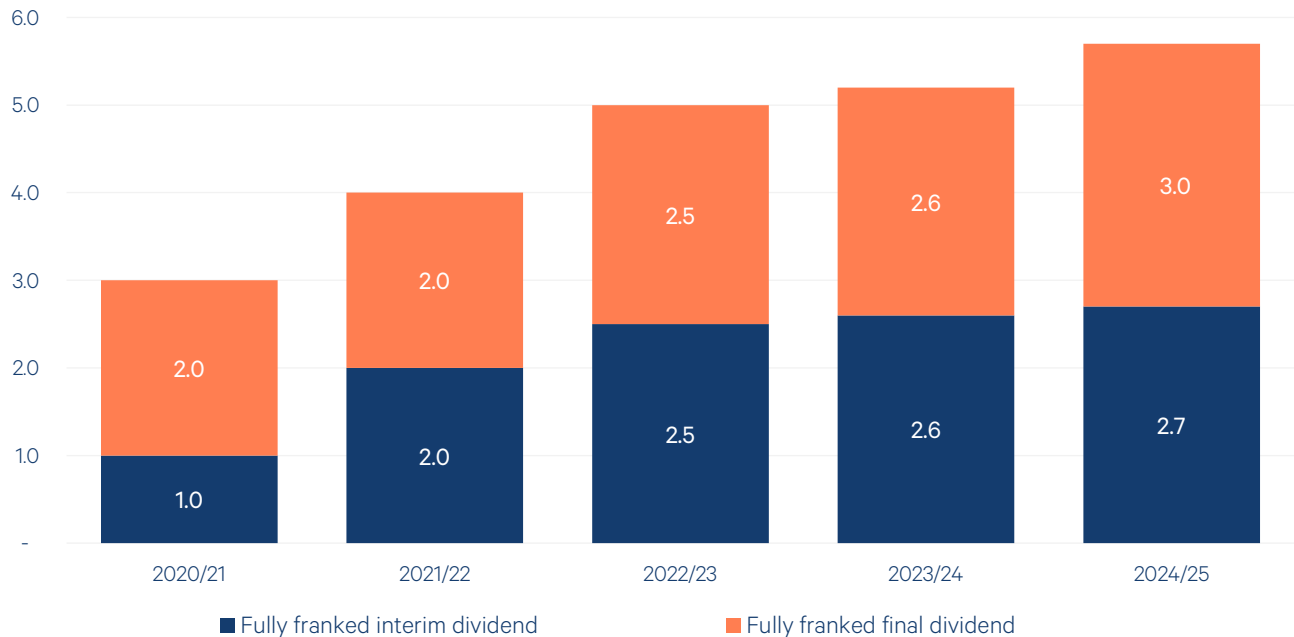

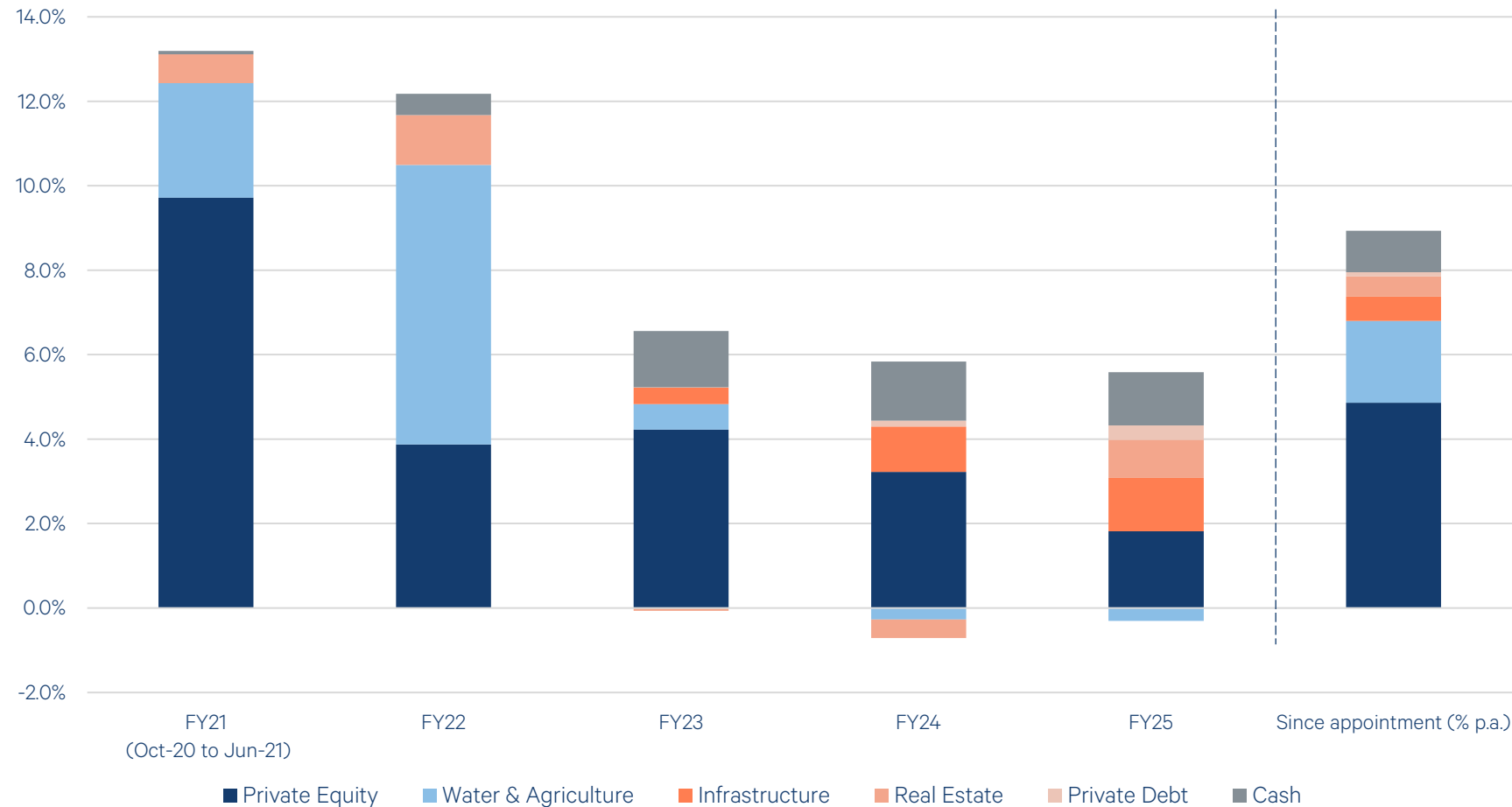

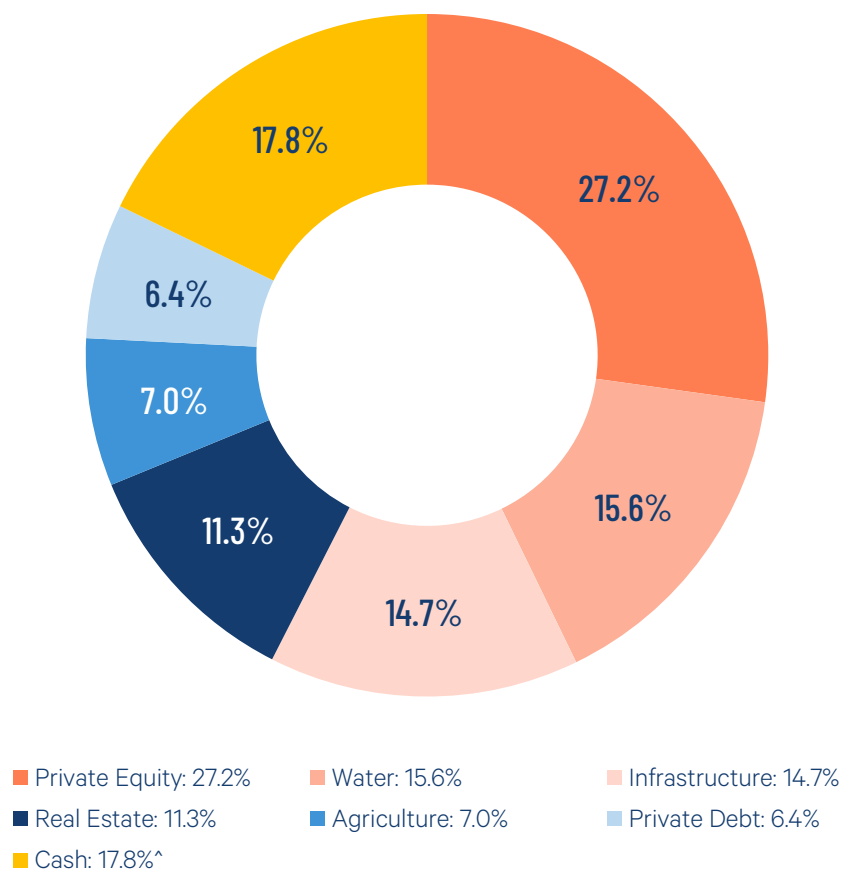

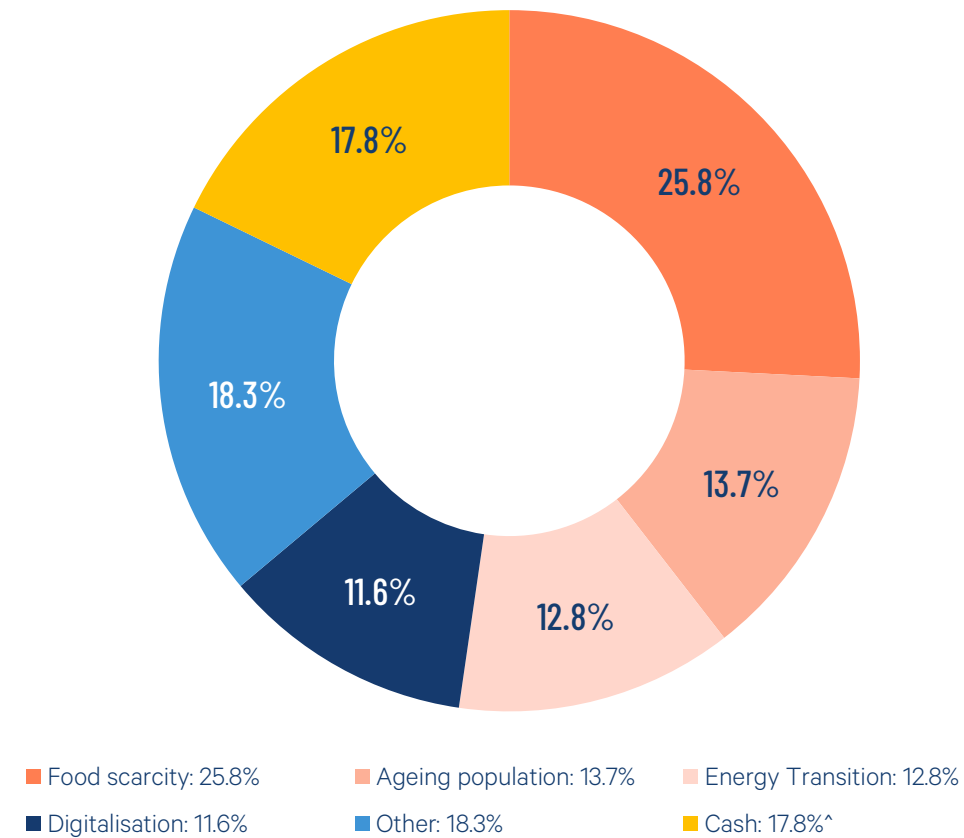

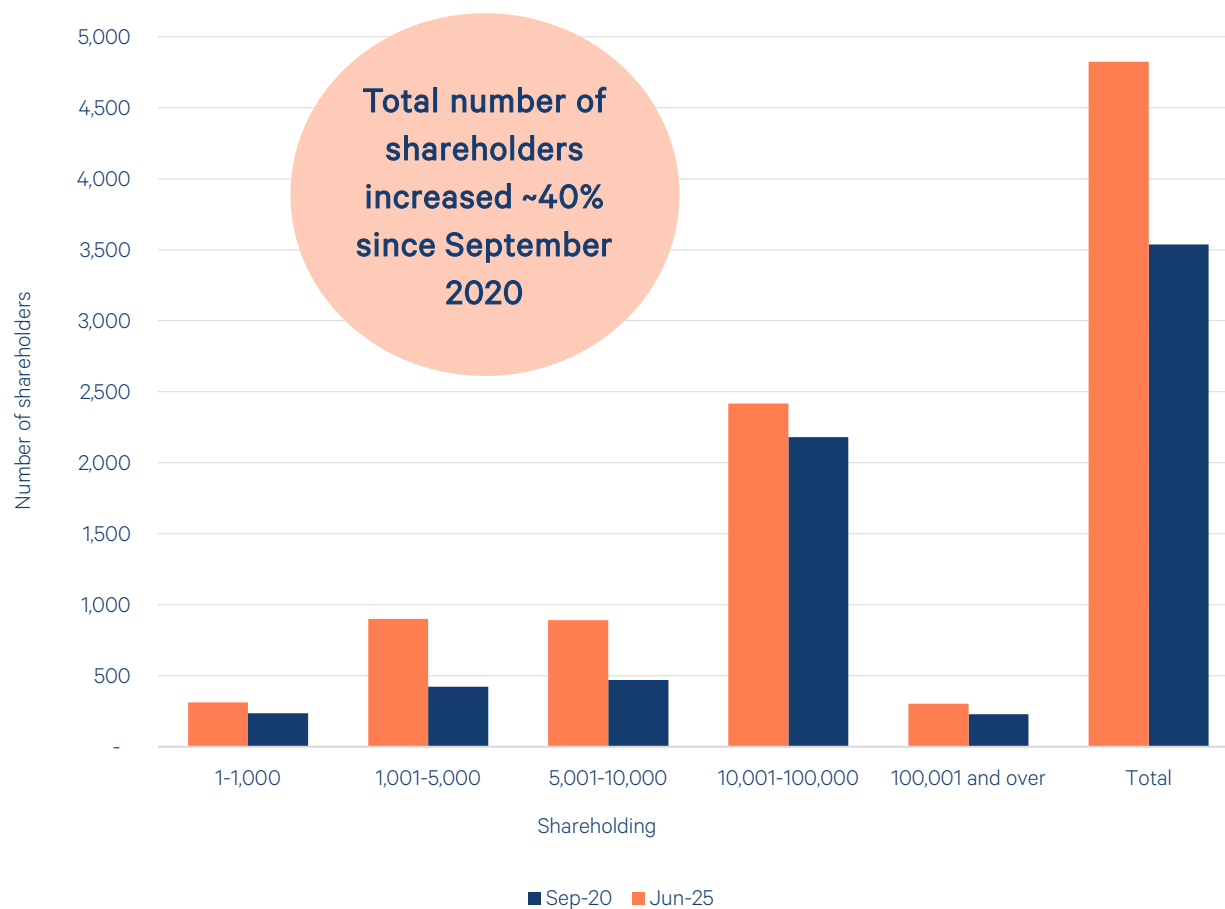

## Evolving share register dynamics



### Better aligned register

- **70%** of current shareholders invested following the appointment of Wilson Asset Management as Investment Manager
- **~45%** of the register hold multiple Wilson Asset Management LICs
- **>30%** of the register holding three or more Wilson Asset Management LICs

## Resolution 4: Approval to terminate the Investment Management Agreement and liquidate the Company

The Directors independent of Wilson Asset Management unanimously recommend that shareholders **VOTE AGAINST** Resolution 4.

The Chairman intends to vote all available proxies **AGAINST** Resolution 4.

### A vote **AGAINST** means:

- The Company will remain listed, providing daily liquidity to investors via the ASX;
- Shareholders will continue to receive a growing stream of franked dividends\*;
- Wilson Asset Management will continue to deploy its best-in-class communications and investor relations expertise, with a focus on narrowing the share price discount to NTA;
- Shareholders will continue to benefit from Wilson Asset Management's portfolio expertise and its ability to redeploy capital into attractive investment opportunities;
- Shareholders will continue to have the opportunity to access WAM Alternative Assets, a unique company and the only LIC on the ASX that offers a diversified portfolio of alternative assets, typically only available to institutional investors; and
- The Company will continue under the Investment Management Agreement with Wilson Asset Management (International) Pty Limited.

\*The Board is committed to paying a stream of franked dividends to shareholders, provided the Company has sufficient profits reserves and franking credits, and it is within prudent business practices.
