#### **Retirement of Non-Executive Director and Chief Financial Officer**

Ashley joined Pacific Current in March 2019 as Interim Chief Financial Officer and was appointed as Chief Financial Officer in October 2020. During his tenure, Ashley has played a pivotal role in strengthening the Company's financial position, driving operational efficiencies, and supporting strategic growth initiatives.

Both Gilles and Ashley have made significant contributions to the success of Pacific Current during their tenure. The Board extends its sincere gratitude to Gilles and Ashley for their outstanding service and leadership and wishes them all the best in their future endeavours.

An executive search process is underway to identify a successor for the Chief Financial Officer. The Board will also consider its structure and composition in light of Mr Guerin's retirement.
