ASX Announcement | Board Succession and Renewal Update

GrainCorp Limited (**GrainCorp** or the **Company**) (ASX: GNC) provides an update on Board succession and renewal, including the appointment of two independent Non-executive Directors, Ms Samantha Hogg and Ms Sarah Adam-Gedge.

Appointment of New Non-executive Directors

GrainCorp is pleased to announce the appointment of Ms Samantha Hogg and Ms Sarah Adam-Gedge as Non-executive Directors of GrainCorp. Ms Hogg will join the Board with effect from 22 September 2025, and Ms Adam-Gedge's appointment will be effective from 1 November 2025.

The appointments follow an extensive search process, informed by a comprehensive review of both current Board skills and of the additional and complementary skills required to support GrainCorp' strategy and broader Board renewal and succession planning.

On behalf of the Board, GrainCorp Chairman, Mr Peter Richards, said:

"We are delighted to welcome Samantha and Sarah to the GrainCorp Board. Their diverse experience and expertise will strengthen the Board's collective capabilities as we remain focused on our strategic priorities to enhance our core business, pursue targeted growth opportunities and advance transformation initiatives."

Mses Hogg and Adam-Gedge will offer themselves for election by shareholders at the next Annual General Meeting in February 2026.

Retirement of Ms Kathy Grigg

Ms Kathy Grigg, Non-executive Director and Chair of the Audit and Risk Committee, has confirmed her intention to retire from the Board at the conclusion of the Annual General Meeting in February 2026. Ms Grigg is an experienced audit and risk committee chair with extensive expertise in finance, risk and operational management gained through her executive and non-executive career in the agricultural sector. Ms Grigg joined the Board in December 2019 and has brought exceptional leadership, expertise and pragmatism during her tenure.

Mr Richards said "Kathy joined the Board prior to the demerger of the Malt business in 2020 which followed a period of prolonged drought. Her steadiness and deliberate approach to managing the transition and changes to our operating model has positioned GrainCorp well for its next phase of growth. My fellow Board members and I join in wishing her well for retirement in February 2026."

The recent external search process was specifically designed to ensure that, following Ms Grigg's retirement, the Board maintains the expertise and capability she currently provides, as well as strengthening the Board's skills to support our strategic priorities, and broadening Board succession options as the business continues to evolve.

Following the conclusion of the 2026 Annual General Meeting, it is intended that Ms Hogg will be appointed as Chair of the Audit and Risk Committee.
