As per the company's announcements on 11 November 2024 and 12 May 2025, DNL has recommenced its previously announced on-market buyback of ordinary shares valued at up to AUD\$400 million (rather than a specific minimum or maximum number of shares), which commenced on 10 July 2024. DNL will only buy back shares at such times and in such circumstances as it considers appropriate.



Part 5 - Final buy-back notification

For on-market buy-backs, a final buy-back notification must be submitted at least half an hour before the commencement of trading on the business day after the company buys back the maximum number of securities that it wanted or the company decides it will stop buying back securities.
