Financial Close of Transurban Queensland's A\$485 million financing

Transurban announces that Transurban Queensland Finance Pty Limited, the financing vehicle of the Transurban Queensland Group (**TQ**), has raised A\$485 million of 10-year debt via an Asian term loan facility (**Facility**).

The Facility will be used to repay existing debt and fund associated transaction costs. Transurban owns a 62.5% interest in TQ.
