At the 2024 Annual General Meeting held on 19 December 2024, DNL received shareholder approval to conduct an on-market buyback of up to 390,000,000 shares, which equates to a buyback of up to \$500 million (the Buyback). DNL intends to undertake the Buyback following the completion of the previously announced on-market share buyback of up to \$400 million on 17 September 2025. DNL will only buy back shares at such times and in such circumstances as it considers appropriate.
