# Post-close of MIXI Takeover Offer and Unsolicited betr Scrip Offer

PointsBet Holdings Limited (ASX: PBH) (**PointsBet**) refers to the off-market takeover offer by MIXI Australia Pty Ltd (**MIXI Australia**) for the ordinary shares in PointsBet (**MIXI Takeover Offer**) and the unsolicited off-market all-scrip takeover offer by betr Entertainment Limited (ASX: BBT) (**betr**) for the ordinary shares in PointsBet (**Unsolicited betr Scrip Offer**).

The MIXI Takeover Offer closed at 7:00 pm (Melbourne Time) on 12 September 2025. As at the close of the MIXI Takeover Offer, MIXI Australia's voting power in PointsBet was 66.43%.

The Unsolicited betr Scrip Offer closed at 7:00 pm (Sydney Time) on 25 September 2025. As at the close of the Unsolicited betr Scrip Offer, betr's voting power in PointsBet was 27.72%.
