On behalf of your Directors, I am pleased to invite you to participate in the Company's share purchase plan by subscribing for fully paid ordinary shares in the Company (**Shares**) up to a maximum subscription of A\$30,000 at an issue price of A\$1.94 per Share (**SPP Offer**). The SPP Offer is offered to Eligible Shareholders under an offer booklet in accordance with *ASIC Corporations* (*Share and Interest Purchase Plans*) *Instrument 2019/547* (**Offer Booklet**).
