Autosports Group completes acquisition of 68-74 Nerang Street & 3-5 Suter Street, Southport

Autosports Group Limited (ASX: ASG) today announces the completion of the acquisition by its wholly owned subsidiary Prestige Group Holdings Pty Ltd of the land and buildings at 68-74 Nerang Street and 3-5 Suter Street, Southport, Gold Coast, Queensland.

The purchase consideration at completion of \$17.6 million, excluding tax and fees, was funded by existing debt facilities. Stamp duty and registration fees were funded from cash reserves.

CEO of Autosports Group, Nick Pagent said: "The acquisition of this 8,785 square metre site in a prime Gold Coast location is consistent with our strategic objective to secure and maintain flagship locations in key metropolitan markets.

As outlined in our FY25 results, we intend to develop a purpose-built Mercedes-Benz facility at this site. We anticipate the development approval and construction process will take approximately two years, with sales operations expected to commence in the meantime from our facility at 138 Ferry Road, Southport in the first half of FY27. Together with our recently-acquired Mercedes-Benz Canberra dealership, this expansion strengthens our Mercedes-Benz representation nationally. We appreciate the ongoing support of Mercedes-Benz."
