Q1 FY26 Operational Cash Inflow Achieved – Q1 EBITDA Positive

September 2025 Quarterly Report and Appendix 4C

Fintech company 8common Limited (**8common** or the **Company**) (ASX: **8CO**), is pleased to release its quarterly cashflow and business update for the quarter ended 30 September 2025 (1Q FY26).

Outlook:

- Growing Transaction and SaaS revenue of \$1.29m (up 8% vs PCP) and gross margin averaging 70% for the quarter delivered a good start to FY26.
- Moving from infrastructure, billing, and technology enhancements in FY25, the Company is now
 focused on expanding product and client segments. These initiatives together with the robust
 pipeline should support expectations for full year positive cashflow and EBITDA.

Key financial highlights during 1Q FY26 include:

- Transaction and recurring SaaS revenue: \$1.29 million, up 8% vs PCP.
- Total revenue: \$1.7 million, down 16% vs PCP.
- Cash receipts from operations: \$1.83 million.
- Net operating cash inflow: \$55k.
- Annualised Recurring Revenue (ARR): ~\$5.2 million (based on Q1 SaaS and transaction revenue of \$1.29m).
- ARPU: \$28.06 with a stable user base of 183,000.
- Operational cost reduction: Total costs down 38% vs PCP, driven by a 45% decrease in Admin and Corporate costs.
- Cash position: \$0.1 million at 30 September 2025 (unchanged from 30 June 2025), supported by a \$1.5 million loan facility. \$50k was repaid during 1Q FY26 leaving \$400k outstanding on the facility at 30 September.

Key operational highlights include:

- Expansion of the Partner network with the successful onboarding of Callida and GreenCloud. This brings the total Partner count to 7 which comprises a mix of specialist and comprehensive large scale firms.
- NSW Department of Education (DoE) renewed their Expense8 contract for a 2-year fixed term representing an estimated value of \$1.56m with two 1-year extensions, representing an estimated total contract value of \$3.54m including GST.

New client engagement has maintained momentum and we look forward to expanding our userbase in the coming quarters."

Financial and operational review


The Company delivered transaction and recurring SaaS revenue of \$1.29 million, up 8% on the previous corresponding period (PCP) and total revenue of \$1.7 million. ARPU for 1QFY26 was \$28.06, with a steady user base of 183k users.

Payments to the Directors of the entity, consisting of salaries and fees for Executive and Non-Executive Director, totalled \$90k during the quarter (see section 6 of the Appendix 4C). No other payments were made to any related parties or their associates of the entity.





Recurring SaaS & Transaction revenue






CardHero

CardHero contributed \$118k in revenue during the quarter and continues to operate cashflow positive. Renewed interest from customers has brought on more pre-sales activity.

Cash Flow performance

Net cash flow from operations for 1Q FY26 was \$55k, supported by strong cash receipts and healthy gross margins which should continue through the rest of the year.

The Company had a cash position of \$0.1 million as at 30 September 2026. The Executive Chairman has provided a loan facility of up to \$1.5 million. \$50k was repaid during the quarter, leaving \$400k outstanding at the end of the quarter. \$1.1m remains available for draw down, if required, under the facility from the Executive Chairman.
