Results of 2025 Annual General Meeting

In accordance with Listing Rule 3.13.2 and section 251AA of the Corporations Act, the results of the 2025 Annual General Meeting (AGM) of Articore Group Limited (ASX:ATG) held on Thursday, 23 October 2025 are set out below. All resolutions put to the AGM were decided by way of poll:

Resolution 1 - Adoption of Remuneration Report - resolution passed (99.62% in favour)

Resolution 2 - Re-election of Director - Robert Sherwin - resolution passed (91.45% in favour)

Resolution 3 – Approval of Non-Executive Director participation in Equity Incentive Plan (EIP) for issue of Equity Securities in lieu of cash fees – resolution passed (99.54% in favour)

Resolution 4 – Ratification of prior issues of shares pursuant to ASX Listing Rule 7.4 – resolution passed (99.89% in favour)

Resolution 5 – Ratification of prior issue of Employee Incentive Securities pursuant to ASX Listing Rule 7.4 – resolution passed (99.82% in favour)

Resolution 6 (Conditional Spill Resolution) was not required to be put to the AGM, due to the votes cast on Resolution 1 being greater than 75% in favour.
