Alligator Investee EnviroCopper Secures Strategic Investment to Progress Feasibility Studies

Highlights:

- EnviroCopper Limited (AGE 15.61% interest) secures \$3.5 million contribution towards feasibility and technical advancement for its ISR copper projects in South Australia
- Alligator can disclose under confidentiality that the international investor is able to convert the \$3.5 million funding into a 16.8% investment in EnviroCopper at any time within a five year period
- . This funding significantly improves the value of Alligator's investment into ECL

Alligator Energy (ASX: AGE, 'Alligator' or 'the Company') is pleased to advise that EnviroCopper Ltd (AGE 15.61% holding) has signed a collaboration partnership with an international company to progress the feasibility work at its Kapunda and Alford Copper ISR Projects. The partnership includes an initial \$3.5 million contribution towards feasibility funding as well as technical collaboration between the companies. The international company may also contribute capital towards project development upon completion of feasibility work.

The funding is subject to agreement by all EnviroCopper shareholders which will be supported by the Company.

Alligator's CEO Andrea Marsland-Smith stated: "This investment into EnviroCopper marks a pivotal step forward in accelerating the technical and feasibility work required to bring its ISR copper projects closer to development. For Alligator, it both supports the investment that Alligator made into ECL, and strengthens the pathway to potential future ISR copper production. Importantly, the collaboration also highlights growing international recognition of the strategic importance of environmentally responsible copper production methods. We are pleased to see EnviroCopper advancing rapidly towards feasibility, and this funding, alongside the technical input from our new partner, reinforces confidence in the long-term value these ISR projects can deliver."

EnviroCopper's MD Leon Faulkner stated: "This collaboration partnership reinforces the potential of alternative recovery processes like in-situ recovery to become an environmentally sustainable and economical path to recover copper minerals. We look forward to building upon ECL's existing ISR team and knowledgebase to continue to develop ISR as a recovery process."
