Q3 FY25 Quarterly Activity Report and Appendix 4C

Appen Limited (Appen) (ASX: APX), a global market leader in data for the Artificial Intelligence (AI) Lifecycle, is pleased to provide this activity report and Appendix 4C for the quarter ended 30 September 2025 (Q3 FY25). Unless noted otherwise, all figures are presented in US\$ and January 2025 to September 2025 are based on unaudited management accounts.

Q3 FY25 Highlights:

- Revenue of \$55.3 million, +2% vs prior corresponding period (pcp)
- Underlying EBITDA¹ (before FX) of \$1.0 million, in line with pcp, and a \$1.6 million improvement on the prior quarter
- Ongoing pleasing quarterly performance achieved in China business, reflected by:
 - o Quarterly revenue of \$28.6 million, +81% vs pcp;
 - o Annualised revenue run-rate exceeding \$115 million in September; and
 - o Expansion of quarterly underlying EBITDA¹ to \$3.3 million, the sixth consecutive quarter of standalone underlying EBITDA¹ profitability
- Previously announced project win with \$10 million+ annual revenue potential successfully transitioned from pilot to full production during Q3 FY25
- Growth in China offset by ongoing volatility and dynamic nature of US AI market
- Continued progress made against planned technology innovation and automation strategy, delivering further annualised cost efficiencies
 - Approximately \$7 million of \$10 million planned annualised cost out has been executed, with the balance targeted by end of Q4 FY25
- Strong cash balance as at 30 September 2025 of \$50.9 million (AUD 77.1 million²)
- Current FY25 guidance reaffirmed:
 - Revenue tracking towards low end of \$235 \$260 million range; and
 - Positive full year underlying EBITDA¹

Commenting on the performance for the quarter, Appen's CEO & Managing Director Ryan Kolln said, "Q3 was another strong quarter for our China business, exiting the quarter with an annualised revenue run-rate growing to over \$115 million - a pleasing result. In addition to the significant revenue growth, the China business improved its underlying EBITDA profitability on the previous quarter by \$1.2 million, reflecting operating leverage as the business continues to scale."

"The remainder of our business has continued to be impacted by volatility due to the dynamic nature of the US AI market. Notwithstanding this, we remain confident the market opportunity remains strong. Appen has been executing against its strategy, resulting in deepened customer relationships and breaking into new accounts, during the quarter. The successful transition of a recent \$10 million plus revenue opportunity from pilot to full production is an example of this progress."

"As the market continues to evolve, the companies best positioned to deliver trusted, scalable data will be those that shape the next generation of Al development. That's where Appen has a unique and powerful role to play."

"With a strong balance sheet and a dedication to delivering quality data at speed we are well positioned for sustained profitable growth. We maintain our focus on revenue growth and ongoing underlying EBITDA profitability."





Group Underlying EBITDA (before FX)




China Business

Appen's China business continued to perform well during the quarter, delivering strong revenue growth (+ 81% vs pcp). The China business exited the quarter with an annualised run-rate for September exceeding \$115 million. Additionally, it achieved standalone underlying EBITDA profitability in Q3 - its sixth consecutive quarter, and a \$1.2 million improvement on the prior quarter.

Other Businesses

The strong growth of the China business was offset by the ongoing volatility and dynamic nature of the US AI market, including uncertainty in relation to timing and volumes for large LLM projects.

The Company remains focussed on continued execution against its near term strategy, including increased technical expertise in the go-to-market and delivery teams. The Company has made further progress in each of these areas during the quarter.

The previously announced project win with \$10 million+ annual revenue potential successfully transitioned from pilot to full production towards the end of Q3 FY25.

Execution of Appen's previously announced ~\$10 million annualised cost efficiencies is going to plan with approximately \$7 million now complete and the balance to be executed by the end of Q4 FY25. These cost benefits were enabled by execution of Appen's near-term strategy of capturing efficiencies through technology innovation and automation. Importantly, these efficiencies are net of talent upgrades required to increase technical expertise.

As also previously announced, due to US policy uncertainty, Appen made the decision to wind back investment in the US Government division. This will result in additional annualised operational expense savings of approximately \$4 million. The majority of this cost-out was executed in Q3 FY25, with the balance expected to be out by the end of Q4 FY25. This is in addition to the \$10 million annualised cost-out as mentioned above.

Guidance

Appen remains confident in its long-term revenue opportunity, including previously provided longer-term targets.

As it relates to the balance of FY25, there remains limited visibility relating to specific timing and volumes of large LLM projects.

Considering this, Appen reaffirms its current FY25 guidance of:

- Revenue towards the low end of the \$235 million to \$260 million range; and
- Positive full year underlying EBITDA.

Notes related to cash balance

Cash on hand as at 30 September 2025 was \$50.9 million, down \$10.0 million from \$60.9 million at 30 June 2025.

Net cash used in operating activities was \$4.9 million for the quarter, compared to \$3.5 million used in operating activities in Q2 FY25. Q3 includes large supplier payments for annual contracts as well as one-off payments relating to execution of cost efficiency plan. Year to date cash from operating activies was \$8.3 million.

Staff costs includes employed direct project workers (crowd expenses). This amount was \$7.7 million for the quarter, up from 6.9 million in 2 FY25. The increase aligns with revenue growth for projects requiring employed project workers.

Net cash used in investing activities was \$4.4 million for the quarter, a small increase compared to Q2 FY25 driven by expansion of facilities for the China business. \$3.0 million outflow in relation to intellectual property refers to capitalised investment in product development.

Appendix 4C item 6.1 includes \$0.3 million aggregate payments to the CEO and Managing Director and Independent Directors. All amounts paid were in their capacity as Executive and Independent Directors.
