## **Results of 2025 Annual General Meeting**

In accordance with Listing Rule 3.13.2 and section 251AA(2) of the *Corporations Act 2001* (Cth) (the **Act**), enclosed is a summary of the resolutions considered, the proxies received and the outcomes of voting for each respective resolution at the 2025 Annual General Meeting (**AGM** or the **Meeting**) of Australian Dairy Nutritionals Limited (**AHF** or the **Group**) held today.

In relation to Resolution 1 (Adoption of Remuneration Report), as more than 25% of the votes were cast against the resolution, this constitutes a second strike for the purposes of the Act.

Resolution 7 Board Spill Meeting (Conditional Item) was not approved by shareholders and therefore a spill meeting is not required to be held within 90 days of the AGM.
