Listings and Capital Raisings

- In October 2025, total new capital quoted was \$9.4 billion, compared to \$3.1 billion in the previous corresponding period (pcp). The total quoted market capitalisation of entities de-listed was \$5.3 billion compared to \$6.7 billion in the pcp.
- Total net new capital quoted was \$4.1 billion, compared to negative \$3.6 billion in the pcp. On a October YTD basis total net new
 capital quoted was \$10.0 billion, compared to negative \$19.6 billion in the pcp.

Trading – Cash Markets (including equities, interest rate and ETP trades)

- In October 2025, the average daily number of trades was up 51% on the pcp. The average daily value traded on-market of \$7.230 billion was up 33% on the pcp.
- Volatility (as measured by the average daily movement in the All Ordinaries Index) was 0.5% in October, compared to 0.5% in the pcp.
- Future volatility (as measured by the S&P/ASX 200 VIX) in October was an average of 11.4, down 7% on pcp.

- Participant margin balances held on balance sheet totalled \$12.6 billion at 31 October 2025, compared to \$12.1 billion at 31 October 2024. Participant margin balances subject to risk management haircuts were \$8.9 billion at 31 October 2025, compared to \$8.0 billion at 31 October 2024.
- Average participant margin balances held on balance sheet were \$11.9 billion for the month of October 2025, compared to \$11.3 billion for the month of October 2024. Average participant margin balances subject to risk management haircuts were \$8.2 billion for the month of October 2025, compared to \$7.0 billion for the month of October 2024.
