## **Alcidion expands contract with Leidos Australia**

## **Highlights:**

- Contract expansion for additional software modules from Miya Precision to enable Leidos to deliver further solution components to the Commonwealth of Australia
- Total contract value (TCV) to Alcidion is \$12.3M over the period to June 2028 (approx. 2.7 years),
  adding ARR of \$2.5M with the balance being implementation revenue
- Alcidion expect to recognise between \$5.5M-\$6.5M of this revenue in FY26
- The initial contract term (to June 2028) aligns with the larger existing contract with Leidos Australia which has possible extensions out to 2036

The total contract value for the expansion is \$12.3M for the period until June 2028, adding a further \$2.5M to our ARR.

Alcidion will commence work immediately and expect to recognise between \$5.5M - \$6.5M of this new revenue in FY26. The contract term (to June 2028) aligns with the larger existing contract with Leidos Australia which has possible extensions out to 2036.
