Acusensus is a technology company that was founded in 2018 with a mission to design and develop artificial intelligence enabled road safety solutions. Collaborating with governments and commercial stakeholders to tackle distracted driving globally is Acusensus' first priority. Acusensus has pioneered intelligent solutions that provide anywhere, anytime digital evidence that can be used in conjunction with law enforcement to drive behavioural change and improve road safety. Acusensus technology is used to detect and provide prosecutable evidence of distracted driving (mobile phone use), seatbelt compliance, speeding, railway crossing compliance and the monitoring of vehicles of interest.

Leveraging AI and sensing expertise, Acusensus also provides technology that protects workers in live traffic environments. The Forsite by Acusensus road worker safety system integrates roadside sensors, connected wearables and real time analytics to give crews early warning of approaching vehicle risks, delivering the vital seconds needed to avoid harm while generating data that helps make worksites safer over time.

Acusensus listed on the Australian Securities Exchange in January 2023. Acusensus is headquartered in Melbourne, Australia, with offices also in Sydney, Brisbane, Perth, Auckland (New Zealand), Wellington (New Zealand), Christchurch (New Zealand), London (United Kingdom) and Las Vegas (United States).

I would like to extend a warm welcome to each and every one of you for attending our 2025 Annual General Meeting. As the Chair of Acusensus Limited, it is once again my privilege to be before you today and to provide an overview of the Company's significant performance over the past year.

Acusensus remains relentlessly focused on its original mission of fostering positive changes in driver behaviour and saving lives. The sobering reality of road fatalities continues to underscore the critical and lifesaving work our technology enables. We are not just an enforcement company; we are a vital contributor to improving road safety globally.

The success we celebrate today is reinforced by the clear execution of our growth strategy across domestic and international markets. In Australia, we have continued to strengthen our domestic foothold. This includes significant expansions in key enforcement programs across Queensland and New South Wales, and the successful ramp-up of our pioneering multi-function enforcement program in Western Australia. Our solutions are now more deeply integrated than ever before, simultaneously addressing distracted driving, seatbelt usage and speed control, delivering value to our partners.

The 2025 financial year has been transformative for our global presence. We successfully deployed a nationwide mobile speed camera enforcement network in New Zealand, marking a significant entry into that market and demonstrating the scalability of our core technology. In the United States, we were awarded the Company's first major state-wide automated enforcement contract with the signing of a five-year agreement for an Automated Work Zone Speed Control program in Connecticut. Finally, we continue to invest in our activities in the United Kingdom, maintaining a strong pipeline of opportunities.

New product development has remained a strong focus, reflecting Acusensus' commitment to solving unaddressed and emerging road safety challenges. Over the year, we progressed the commercialisation of our road worker safety platform, Forsite Connected Safety, including entering our first long-term agreement with Fulton Hogan and commencing early deployments across selected worksites. This work is an important step in digitising work zones and building the data foundation needed to enhance safety outcomes for crews along the road. Alongside this innovation, we have continuously enhanced our existing solutions, ensuring we remain at the cutting edge of multi-function enforcement.

We will continue to execute our vision to be a leading multi-function enforcement technology provider globally. We are supported by strong partnerships, a powerful product portfolio and a strategy that is delivering tangible results on the ground.

On behalf of the Board, I express our gratitude to our dedicated employees, whose commitment and passion is integral to the success of Acusensus. To all of our shareholders, we extend our sincere thanks for your ongoing support.

We look forward to an exciting year of continued innovation, international growth, and most importantly, safer roads.
