Clearview Wealth Limited ('CVW'): Appendix 3Y – Amended Change of Director's Interest Notice

We refer to the Appendix 3Y for Nadine Gooderick lodged with the ASX on 14 November 2025. Following discussions with the ASX Listings Compliance team about whether the Appendix 3Y was lodged late (outside the timeframe specified in Listing Rule 3.19A.2), we provide an amended Appendix 3Y which we confirm was lodged in compliance with Listing Rule 3.19A.2, for the reasons set out below:

- 1. A change in Ms Gooderick's notifiable interest was approved by shareholders at the Annual General Meeting held on 6 November 2025.
- Whilst shareholders approved the grants of rights to Ms Gooderick on this date, under the ClearView Wealth Limited Plan STVR and LTVR Rules, a Grant Notice is required to be executed before the rights are issued.
- 3. Following internal process, the Grant Notice was executed on 13 November 2025, the rights were issued and the Appendix 3Y relating to the change in Ms Gooderick's interests was lodged the following day, together with an accompanying Appendix 3G which showed the date of issue of the rights on 13 November 2025.
- 4. As a result, an amended Appendix 3Y is attached showing the revised Grant Date of 13 November 2025.
