On 20 October 2025, Zip announced an increase in the size of its on market buy back program from up to \$50 million of ordinary shares to up to \$100 million of ordinary shares. As at 20 October 2025, approximately 17.8 million ordinary shares had been purchased and cancelled under the program, for a total consideration of approximately \$43.4 million.



Part 5 - Final buy-back notification
