At the 2025 Annual General Meeting held on 17 December 2025, DNL received shareholder approval to continue the on-market buyback of up to 250,000,000 Shares, which equates to a buyback of up to \$470 million. DNL will only buy back shares at such times and in such circumstances as it considers appropriate.



Part 5 - Final buy-back notification
