CAQ Holdings Limited December 2025 Quarter Activities Report

Operations Review

The property leasing business decreased in December 2025 Quarter. Leasing revenue totalled RMB1.1 million (AUD 238k) during the December 2025 Quarter, which represented a reduction of approximately 8%, from RMB1.2 million (AUD 257k) in the September 2025 Quarter, due primarily to non-renewal following the expiry of certain leases of the factories and warehouses.

The status of the exhibition centre remained unchanged from the September 2025 Quarter.

The existing vacancy (including areas subject to negotiation) rate being:

Warehouse (41,750m ²)	77%	(40% in September 2025)
Factories (17,784m ²)	67%	(67% in September 2025)
Exhibition Centre*	95%	(95% in September 2025)
Administrative Building	46%	(46% in September 2025)

Since the formal implementation of the island-wide independent customs operation of the Hainan Island on 18 December 2025, the negotiation of tenancy became active. The tenancy of the third to fifth floors of the administrative building hopefully can be signed in February. Several new tenancies of the exhibition centre are actively negotiated and hopefully can be signed in the first quarter of 2026. It is expected that the rental income arising from property leasing will be increased too.

During the December 2025 Quarter CAQ's receipts from customers was \$0.24m (RMB1.1 million) which was increased from the September 2025 Quarter \$0.16m (RMB0.77 million).

Financial

At the end of the Quarter the Group had cash at bank of \$0.279m.

Payments to director related parties and their associates during the quarter totalled \$Nil.
