QUARTERLY ACTIVITIES REPORT

MELBOURNE, AUSTRALIA (30 January 2026): Hexima Limited (ASX:HXL) (**Hexima** or **Company**) today releases its Appendix 4C and sets out below its quarterly activities report for the quarter ended 31 December 2025.

Hexima continues to evaluate strategies and opportunities for the benefit of the company and its shareholders, including the possibility of a capital return to shareholders.

Financial update

Hexima closed the quarter with a total cash balance of \$1.4m.

During the quarter net cash of \$38k was used in operating activities, comprising interest received of \$20k, and net operating expenditures of \$58k, which largely comprised ongoing compliance costs and professional fees.

In accordance with Listing Rule 4.7C disclosure requirements, payments made to related parties and their associates included in item 6.1 of the Appendix 4C represented payments for directors' fees and remuneration in the normal course of business at commercial rates, excluding reimbursements for out-of-pocket expenses.
