Notice under section 708A(5)(e) of the Corporations Act 2001


This notice is given by AUB Group Limited (ACN 000 000 715) (ASX: AUB) (**AUB**) under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (**Act**).

AUB today issued 13,605,443 fully paid ordinary shares (**Shares**) at an issue price of AUD 29.40 per Share to institutional investors under the fully underwritten institutional placement announced on 27 January 2026.
