Post-close of Novomatic AG Takeover Offer and Kjerulf David Hastings Ainsworth Proportional Takeover Offer

Ainsworth Game Technology Limited (ASX: AGI) (**Ainsworth**) refers to the off-market takeover offer by Novomatic AG (**Novomatic**) for all the ordinary shares in Ainsworth which Novomatic does not already own (**Novomatic Takeover Offer**) and the unsolicited proportional off-market takeover offer by Kjerulf David Hastings Ainsworth (**KDHA**) for 2.9% of each shareholder's ordinary shares in Ainsworth that KDHA does not own (**KDHA Proportional Offer**).

The Novomatic Takeover Offer closed at 7:00 pm (Sydney Time) on 6 February 2026. As at the close of the Novomatic Takeover Offer, Novomatic's voting power in Ainsworth was 66.84%.

The KDHA Proportional Offer closed at 7:00 pm (Sydney Time) on 30 January 2026. As at the close of the KDHA Proportional Offer, KDHA's voting power in Ainsworth was 7.28%.
