Appointment of Chief Financial Officer

OFX Group Ltd (“OFX” or “the Group”) (ASX: OFX) today announces the appointment of James Georgeson as Chief Financial Officer (CFO).

Mr Georgeson will commence with the Group on 23 February 2026. As announced on 5 February 2026, OFX’s current CFO, Ms Selena Verth, will remain with the Group until 30 June 2026, and Mr Georgeson and Ms Verth will work together to ensure a smooth transition.

Mr Georgeson brings to OFX a strong track record as a finance leader with extensive financial services experience as a CFO. For the past two-and-a-half years Mr Georgeson was CFO of ASX-listed EML Payments, which has ~450 employees operating across ~30 countries, including twelve months working in London to support their European business.

Prior to this, Mr Georgeson held a range of roles with AMP over more than 20 years, the last four of which were as Group CFO where he oversaw a number of large-scale M&A transactions and transformation programs. This included leading the separation of AMP’s legacy life insurance business and the sale of its investment management business. He was also CFO, Director of Strategy and Chief Risk Officer at AMP’s New Zealand business.

OFX CEO and Managing Director, Skander Malcolm, said “We are delighted to welcome James to join OFX as our new CFO. His mix of international, industry and public company experience including in running major transformation and M&A programs is ideal for OFX as we continue to execute on our 2.0 strategy and as we progress our strategic review.”

Mr Georgeson holds a Bachelor of Accounting from University of Technology, Sydney and a Master of Commerce in Professional Accounting from Macquarie University. He is a Chartered Accountant and also a Graduate of the Australian Institute of Company Directors.

Mr Georgeson’s appointment is initially on a contract basis until 31 March 2027, noting the recently announced strategic review.
