Attention: Listings Compliance

We write to notify ASX of an inadvertent and unintentional exceedance of the **20% takeover threshold under the Corporations Act 2001 (Cth)** in relation to ARC Funds (ASX:ARC).

On **4 March 2026**, Mason Stevens relevant interest (**via custody**) in **ARC** temporarily exceeded the 20% threshold prescribed under the takeover provisions of the Corporations Act. Mason Stevens has reviewed the circumstances surrounding the exceedance and confirms that it was not at all deliberate in nature and completely inadvertent. It was identified promptly, and immediate action was taken to address the position.

The holding was reduced on **6 March 2026**, and the Company's relevant interest is now confirmed to be below the 20% threshold as per the attached notice (**19.9278%**).

Ongoing monitoring and controls remain in place to support continued compliance with the takeover provisions of the Corporations Act.
