Ainsworth Game Technology Ltd – First Supplementary Bidder’s

## Kjerulf David Hastings Ainsworth – First Supplementary Bidder's Statement

---

### 1 Introduction

---

This document is a supplementary bidder's statement under section 643 of the *Corporations Act 2001* (Cth) (**Corporations Act**). It is the first supplementary bidder's statement (**First Supplementary Bidder's Statement**) issued by Kjerulf David Hastings Ainsworth (**Mr Ainsworth**) in relation to his off-market takeover bid for 5.5% of the fully paid ordinary shares in Ainsworth Game Technology Ltd ACN 068 516 665 (**AGI**). This First Supplementary Bidder's Statement supplements, and should be read together with, Mr Ainsworth's bidder's statement dated 12 March 2026 (**Original Bidder's Statement**). Unless the context otherwise requires, terms defined in this First Supplementary Bidder's Statement have the same meaning as in the Original Bidder's Statement. This First Supplementary Bidder's Statement is dated 30 March 2026 and was lodged with ASIC and given to ASX on that date. Neither ASIC, nor the ASX, nor any of their respective officers takes any responsibility for the content of this First Supplementary Bidder's Statement.

### 2 Offer is open for acceptance

---

On 11 March 2026, Mr Ainsworth announced his intention to make an off-market takeover bid for 5.5% of the fully paid ordinary shares in AGI at an **offer price of \$1.30 per Share**. As announced to the ASX on 27 March 2026, Mr Ainsworth has now completed dispatch of the Original Bidder's Statement to the holders of securities in AGI as at 7.00pm (Sydney time) on 16 March 2026 (being the Register Date).

Accordingly, the Offer is now open for acceptance until 7.00pm (Sydney time) on 27 April 2026 (unless extended or withdrawn).

### 3 ASIC relief

---

Mr Ainsworth advises that ASIC has made a declaration under section 655A(1) of the Corporations Act that section 633(1B) of the Corporations Act, as notionally inserted by *ASIC Corporations (Takeover Bids) Instrument 2023/683*, be modified so that Mr Ainsworth can disclose the number of Shares he has a relevant interest in, his voting power in AGI, and the consideration paid for any Shares he has purchased during the 4 months before the date of the Offer, as at a date that is no more than 4 trading days prior to the date of the Offer, rather than as at the date of the Offer (refer to sections 4.2 and 4.3 of the Original Bidder's Statement). This declaration was obtained by Mr Ainsworth to facilitate the exercise of his right to acquire Shares on-market at or below the Offer price until the Offer opens (refer to section 8.1 of the Original Bidder's Statement).

Pursuant to the terms of the declaration, Mr Ainsworth now advises that as at 27 March 2026:



- Mr Ainsworth's voting power in AGI was 8.24%; and
- Mr Ainsworth had a relevant interest in 27,748,217 of Shares.

Mr Ainsworth also advises that neither Mr Ainsworth nor any associate of Mr Ainsworth has provided, or agreed to provide, consideration for Shares under any purchase or agreement during the period 4 months before 27 March 2026 (being the date of the Offer), except as described in Schedule 1.


