

## Insignia Financial Limited to be removed from the S&P/ASX 200 Index

**SYDNEY, APRIL 13, 2026:** S&P Dow Jones Indices announced today that it will remove Insignia Financial Limited (XASX: IFL) from the S&P/ASX 200 Index, subject to final court approval whereby the company will be acquired by Daintree BidCo Pty Ltd.

S&P Dow Jones Indices will remove Insignia Financial Limited from the S&P/ASX 200 effective prior to the open of trading on Monday, April 20, 2026. Insignia Financial Limited will be replaced by 4DMedical Limited (XASX: 4DX), in the S&P/ASX 200 effective prior to the open of trading on Monday, April 20, 2026.
