PWR advises that, following Sharyn Williams' commencement as Managing Director and Chief Executive Officer on 21 April 2026, Matthew Bryson will return to his role as Chief Technical and Commercial Officer. Mr Bryson will also assume an Executive Director role effective 1 July 2026.

Mr Bryson has served as Acting Chief Executive Officer of PWR since April 2025 and Chief Technical and Commercial Officer since August 2021.

After joining PWR in 2000 as a design and manufacturing engineer, Mr Bryson worked as the Engineering Manager for 15 years before being appointed Chief Operating Officer in 2020.

Mr Bryson is responsible for the Technical and Commercial operations of PWR, working with his team to develop solutions and foster relationships with customers across a range of industries.

Mr Bryson completed his Mechanical Engineering Trade as a special class Fitter and Machinist/ Toolmaker. During his early years at PWR, he also studied Mechanical Engineering and worked as a design engineer applying his combined engineering and trade skills to the motorsport and automotive sectors. This experience underpins his ongoing focus on design, product development, and manufacturing with a strong emphasis on innovation and advancing technical capability within PWR.
